Pursuant to rule 19 of the Utah Rules of Appellate Procedure, Respondents, all 104 Legislators of the 62nd Utah State Legislature (Legislators), by and through their counsel of the Office of Legislative Research and General Counsel, file this response to the Petition for Extraordinary Writ.

#### INTRODUCTION

In their Petition for Extraordinary Writ (Petition), Petitioners seek (1) findings on the constitutionality of the Legislature's conduct in considering H.B. 3001, which amended provisions of the voter-enacted medical cannabis initiative, Proposition 2, (2) an order compelling legislation to enable special sessions for the people, and (3) an order compelling the Lieutenant Governor to accept their referendum application. Legislators respectfully request that the Court deny the Petition as it relates to them on these requests for relief because (1) Petitioners lack standing; (2) Legislators are immune from liability for their legislative actions in passing H.B. 3001, (3) Legislators are not the proper parties for the remedies Petitioners seek and the Court may not compel legislation, (4) Petitioners' underlying arguments lack merit, and (5) the Petition fails to comply with rule 19 of the Utah Rules of Appellate Procedure.

#### FACTUAL BACKGROUND

Legislators provide the following factual background relevant to a determination of the Petition as it pertains to their response.

- 1. On November 26, 2018, Lieutenant Governor Spencer J. Cox certified the enactment of Proposition 2 by statewide initiative. (State Board of Canvassers' Certification and report of votes cast for Proposition 2, attached as Addendum A).

  Proposition 2 was titled the Utah Medical Cannabis Act.
- 2. On November 26, 2018, the Health and Human Services Interim

  Committee of the Utah Legislature considered draft legislation proposed for the 2018

  Third Special Session of the Utah Legislature. (Health and Human Services Agenda, attached as Addendum B).
- 3. On November 30, 2018, Governor Gary R. Herbert issued a Proclamation convening the Legislature into Special Session to consider "[a]mending the Utah Medical Cannabis Act and related provisions." (Governor's Proclamation, attached as Addendum D).
- 4. On December 1, 2018, five days after the State Board of Canvassers certified the results, Proposition 2 became effective law.
- 5. On December 3, 2018, pursuant to the Governor's Proclamation, the 62nd Utah State Legislature convened for the 2018 Third Special Session. In their consideration of H.B. 3001, the Utah Medical Cannabis Act, H.B. 3001 was read three times in the House, as required by the Utah Constitution.<sup>3</sup> (House Journal, p. 4, attached as Addendum E). The Senate voted by a two thirds majority to suspend the constitutional

three readings requirement.<sup>4</sup> (Senate Journal, pp. 6–7, attached as Addendum F). H.B. 3001 passed in the House with a two-thirds vote (House Journal, pp. 7–8, attached as Addendum E), and in the Senate with a two-thirds vote (Senate Journal, p. 7, attached as Addendum F). H.B. 3001 was then enrolled and enacted into law upon signature by the Governor. (Governor's Letter, attached as Addendum G).

#### **ARGUMENT**

#### POINT I

#### CLASS 1 PETITIONERS LACK STANDING.

Petitioners claim that two classes of persons' interests may be substantially affected by the issues.<sup>5</sup> Class 1 Petitioners are "legal voters who exercised their constitutional rights to enact public policy via the Initiative process," and Class 2 Petitioners are Maxfield, Newby, and Grant, who filed a referendum application with the Lieutenant Governor's Office, which denied the application.<sup>6</sup> This Court should deny the Petition as to Class 1 Petitioners, because they do not have standing to bring the Petition under either the traditional or the public interest standing doctrine.

Class 1 Petitioners lack traditional standing because they have no personal stake in the controversy. Their asserted interest in the Petition is solely that they "are legal voters who exercised their constitutional rights to enact public policy via the Initiative process"

and who were allegedly denied that right.<sup>7</sup> Unlike Class 2 Petitioners, Class 1 Petitioners did not file a referendum application.<sup>8</sup> This Court, in *Gregory v. Shurtleff*, determined that the appellants' status as voters was, alone, insufficient to satisfy traditional standing to challenge article X of the Utah Constitution.<sup>9</sup> Likewise, here, Class 1 Petitioners' status as legal voters who exercised their rights of initiative is not enough to satisfy traditional standing.

Class 1 Petitioners lack public interest standing because they are unable to show they are "appropriate part[ies] raising issues of significant public importance." This Court has explained that an appropriate party is one with "the interest necessary to effectively assist the court in developing and reviewing all relevant legal and factual questions" and one who is able to show that "the issues are unlikely to be raised if the party is denied standing." Little is known about Class 1 Petitioners other than their assertion that they are "legal voters who exercised their constitutional rights to enact public policy via the Initiative process" and were allegedly denied that right. Even assuming Class 1 Petitioners are able to develop and review all relevant legal and factual questions, which is unknown, their issues are likely to be raised by the Class 2 Petitioners. Consequently, the Court should deny the Petition as to Class 1 Petitioners

because they lack standing to bring their claims under the traditional standing doctrine or under the public interest standing doctrine.

#### **POINT II**

### LEGISLATORS ARE IMMUNE FROM SUIT UNDER THE PRINCIPLE OF LEGISLATIVE IMMUNITY AS EXPRESSED IN THE SPEECH OR DEBATE CLAUSE OF THE UTAH CONSTITUTION.

The Petition must be denied as to Legislators because Legislators have absolute legislative immunity for all actions taken in the sphere of legitimate legislative activity. Petitioners suggest that Legislators "usurp[ed]" Petitioners' right to initiative and referendum because the Legislature, after "suspend[ing] its normal rules of requiring public hearing," and in "less than four hours," passed H.B. 3001 by two-thirds vote in both houses. The actions Petitioners complain of were votes freely made by individual Legislators in their official capacity as legislators, and in the sphere of legitimate legislative activity. Therefore, those actions are shielded from suit under the Speech or Debate Clause.

Article VI, section 8 of the Utah Constitution provides that "for words used in any speech or debate in either house, [members of the Legislature] shall not be questioned in any other place." This provision is almost identical to the Speech or Debate Clause of the Constitution of the United States found in Article I, section 6, which provides that "for any Speech or Debate in either House, [Senators and Representatives] shall not be

questioned in any other Place."<sup>14</sup> While there is little case law interpreting Utah's Speech of Debate Clause, *Riddle v. Perry* suggests that Utah courts would look to federal case law in interpreting the Clause.<sup>15</sup> In interpreting the Speech or Debate Clause of the Constitution of the United States, the Supreme Court has consistently held that the Clause provides civil and criminal immunity to legislative branch members engaged in activities within the legitimate legislative sphere.<sup>16</sup>

Legislative immunity protects legislators from both individual liability and the burden of defending a lawsuit.<sup>17</sup> Legislative immunity under the Speech or Debate Clause is an important safeguard of legislative independence within the framework of a separation of powers.<sup>18</sup> The Speech or Debate Clause ensures that "the legislative function the Constitution allocates to [the legislative branch] may be performed

independently,"<sup>19</sup> leaving legislators "free to represent the interests of their constituents without fear that they will be later called to task in the courts for that representation."<sup>20</sup>

Here, Legislators properly convened after the Governor's Proclamation called them into special session to amend the law passed by initiative (Proposition 2).<sup>21</sup> During the 2018 Third Special Session, Legislators properly exercised their constitutional power to suspend, by two-thirds vote, the requirement that a bill be read by title three separate times in each house, which is customary practice for a special session.<sup>22</sup> The House of Representatives and Senate each passed H.B. 3001 by a two-thirds vote of the members.<sup>23</sup>

Legislative conduct that gave rise to Petitioners' claims, such as convening upon the Governor's proclamation for a special session; suspending Legislative rules; and voting and passing legislation by two-thirds, are within the sphere of constitutional and

legitimate legislative activities and are therefore shielded by the Speech or Debate Clause. The Court should deny the Petition as to Legislators because Legislators are immune from suit.

#### **POINT III**

### LEGISLATORS ARE NOT THE PROPER PARTIES TO THE PETITION AND THE COURT MAY NOT ORDER THE LEGISLATURE TO PASS LEGISLATION.

#### A. Legislators are not the proper parties for the remedies Petitioners seek.

To the extent Petitioners seek an order from the Court compelling the Lieutenant Governor to accept their referendum application or otherwise proceed with their referendum, <sup>24</sup> Legislators are not the proper parties to this Petition. As members of the Legislative Branch, Legislators have no enforcement authority over the complained of provisions of the Election Code, <sup>25</sup> or any others. <sup>26</sup> Members of the Executive Branch, not Legislators, are the proper defendants.

#### B. This Court may not order the Legislature to create enabling legislation.

Petitioners alternatively ask the Court to "order the Legislature to create enabling legislation to grant the People the co-equal right for 'special sessions." This prayer for relief reflects Petitioners' continued confusion about separation of powers between the

branches. The separation of powers between the legislative and judicial branches prevents judicial interference into lawmaking, thereby "preserv[ing] the integrity of functions lawfully delegated to political branches of the government and avoid[ing] undue judicial involvement in specialized operations in which the courts may have little knowledge and competence." Our constitutional system is designed for the *people*, through their elected representatives and through the right to initiative, to pass legislation. As such, the Court may not order the Legislature to create enabling legislation to grant the people ability to call special sessions.

#### **POINT IV**

#### PETITIONERS' UNDERLYING ARGUMENTS LACK MERIT.

### A. The Governor did not exceed his authority in calling a special session and he did not veto Proposition 2.

The Governor properly called a special session on December 3, 2018 pursuant to his constitutional authority under article VII, section 6(1).<sup>29</sup> Contrary to Petitioners' assertion, the plain language of article VII, section 6 does not require "exigent circumstances" for a special session.<sup>30</sup> Instead, it allows the Governor to convene a

special session "on extraordinary occasions" for stated purposes.<sup>31</sup> Accordingly, the Governor issued a Proclamation convening the Legislature into special session for the stated purpose of "[a]mending the Utah Medical Cannabis Act and related provisions."<sup>32</sup>

Petitioners' claim that the Governor effectively vetoed Proposition 2 is likewise inaccurate.<sup>33</sup> The Governor did not veto a law adopted by the people through an initiative. Instead, the legislative branch properly enacted Proposition 2 on December 1, 2018, five days after the Board of Canvassers certified the results of the election.<sup>34</sup> Thereafter, in a special session called by the Governor, the Legislature introduced H.B. 3001, which amended provisions of the law enacted as a result of the passage of Proposition 2.<sup>35</sup> Both the House of Representatives and the Senate passed H.B. 3001 by a vote of more than two-thirds of their members.<sup>36</sup> H.B. 3001 was then presented to the Governor and signed into law.<sup>37</sup>

#### B. The plain language of the Utah Constitution permits the two-thirds exception.

Although Petitioners' argument is difficult to follow, Petitioners appear to argue that the two-thirds vote exception explained in article VI, section 1(2)(a)(i)(B) and Utah Code section 20A-7-102(2) cannot apply to legislation that amends a law passed by initiative.<sup>38</sup> Petitioners cite article 1, sections 2 and 27, and article VI, section 1 of the Utah Constitution to support their argument, but fail to reconcile those provisions with article VI, section 1(2)(a)(i)(B).<sup>39</sup> Petitioners appear to want the Court to rewrite a provision of the Utah Constitution, which the Court clearly may not do.<sup>40</sup>

The bottom line is that the plain language of article VI, section 1 belies

Petitioners' interpretation. Article VI, section 1(2)(a)(i)(B) plainly permits legal voters to

"require any law passed by the Legislature except those laws passed by a two-thirds vote

of the members elected to each house of the Legislature, to be submitted to the voters of
the State, as provided by statute, before the law may take effect." In this case, the

Legislature amended the law enacted by initiative (Proposition 2) and passed H.B.3001.

H.B. 3001 constitutes "any law passed by the Legislature."

#### C. H.B. 3001 passed with a two-thirds vote of all members of both houses.

Petitioners complain that the Lieutenant Governor unconstitutionally denied Petitioner Newby's referendum application under Utah Code Subsection 20A-7-302(2)(b)(ii) because he had not voted in the previous three years. <sup>42</sup> It is not necessary to reach Petitioners' constitutional argument because the Lieutenant Governor had an independent reason to deny the Petitioners' referendum application under article VI, section 1 of the Utah Constitution, which permits Utah voters to "require any law passed by the Legislature, *except those laws passed by a two-thirds vote of the members elected to each house*, to be submitted to the voters." H.B. 3001 passed by two-thirds vote of the Senate and the House of Representatives, which means the Utah Constitution prohibits submitting H.B. 3001 to the voters for referendum.

#### **POINT V**

#### THE PETITION FAILS TO COMPLY WITH RULE 19.

The Court should deny the Petition because Petitioners fail to comply with several provisions of Rule 19. Petitioners failed to comply with rule 19(b)(4), requiring a petition to state the reasons why no other plain, speedy, or adequate remedy exists and why the writ should issue; with rule 19(b)(5), requiring a petition to state why it is impractical or inappropriate to file the petition for a writ in the district court; with rule 19(a)(6), requiring copies of any order or that may be essential to an understanding of the matters

set forth in the petition; with rule 19(b)(7), requiring a memorandum of points and authorities in support of the petition; and, finally, with rule 19(a), requiring a petition to be served personally on the respondent.

### A. Petitioners fail to state why no other plain, speedy, or adequate remedy exists and why the writ should issue.

This Court should deny the Petition based on Petitioners' failure to comply with rule 19(b)(4). This Court's authority to grant a petition for extraordinary writ is limited to circumstances where the petitioner possesses no other plain, speedy, or adequate remedy. 44 Petitioners do not adequately explain why they have no plain, speedy, or adequate remedy before them. They claim they were denied the right to a referendum because they had only five days to submit an application and only 40 days to gather signatures. 45 Petitioners imply this timeline necessitates this Court's action to protect and restore their fundamental right. 46 But this reasoning is insufficient to carry their burden of explaining why no other plain, speedy, or adequate remedy exists.

### B. Petitioners fail to state why it is impractical or inappropriate to file the petition for a writ in the district court.

This Court should deny the Petition because Petitioners fail to comply with the requirements of rule 19(b)(5). Rule 19(b)(5) expressly requires that a petition for extraordinary writ explain why it was impractical or inappropriate to file the petition in district court.<sup>47</sup> The Petition contains no statement explaining why the district court is an impractical or inappropriate forum. This Court has previously established in other election-related matters that the district court possesses sufficient authority to provide relief.<sup>48</sup> The Court should deny the Petition because Petitioners wholly fail to carry their burden under rule 19(b)(5).

#### C. Petitioners fail to meet several other requirements of rule 19.

In addition to failing to meet requirements under rule 19(b)(4) and rule 19(b)(5), Petitioners fail to provide a memorandum of points and authorities in support of the Petition,<sup>49</sup> fail to include copies of parts of the record that may be essential to understanding the matters set forth in the Petition,<sup>50</sup> and fail to personally serve the Petition on Legislators.<sup>51</sup> The Court should deny the Petition because Petitioners fail to meet these fundamental requirements for a petition for extraordinary relief.

#### MISCELLANEOUS BUSINESS

Roll call showed all members present except for Representatives Marc Roberts and Elizabeth Weight, excused.

Speaker Hughes announced that pursuant to Joint Rule 2–1–101, the Rules adopted by the Legislature during the 2018 Second Special Session apply to the conduct of the House during the 2018 Third Special Session.

The Speaker appointed Representatives Craig Hall, Carl Albrecht, and Lynn Hemingway as a committee to meet with a like committee from the Senate to wait upon the Governor to inform him that the Legislature is organized and ready to receive any communication or message he may have to offer.

The Speaker appointed Representatives Kelly Miles, Lee Perry, and Sandra Hollins as a committee to notify the Senate to inform that Honorable Body that the House is organized and ready to do business.

On motion of Representative Wilson, as allowed by the Utah Constitution and the Joint Rules of the Legislature, the House voted to continue its practice of reading only the short title of bills and resolutions as they are introduced or considered on a House Calendar and not read the long title of the bills and resolutions unless a majority of the House directs the reading of the long title, short title, or both of any House or Senate bill or resolution.

On motion of Representative King, the House voted to suspend the rule requiring that bills and resolutions remain on a calendar for one legislative day between second and third readings and that the House also suspends the House Rule requiring a favorable recommendation from a House Standing Committee prior to passage of bills and resolutions.

Senators Todd Weiler, Jake Anderegg, and Luz Escamilla formally notified the House of Representatives that the Senate is organized and ready to do business. Representative Miles reported that his committee has waited upon the Senate and they are organized and ready to do business.

Representative Hall reported that his committee has waited upon the Governor and informed him that the Legislature is organized and ready to do business.

#### INTRODUCTION OF BILL

**H.B. 3001**, **Utah Medical Cannabis Act** (G. Hughes), was read the first time by short title and referred to the Rules Committee.

#### MISCELLANEOUS BUSINESS

On motion of Representative Noel, the House voted to lift **H.B. 3001** from the Rules Committee, read it for the second time, and place it on the Third Reading Calendar.

#### THIRD READING CALENDAR

**H.B. 3001**, UTAH MEDICAL CANNABIS ACT, *Representative Hughes*, was read the third time by short title and placed on its final passage.

On motion of Representative Dunnigan, the House voted to delete **H.B. 3001** in title and body and insert **6th Sub. H.B. 3001** in lieu thereof.


