According to the notice by the Clerk dated January 24, 2019 (Notice) in this case.

Attached Exhibit A:

"Pursuant to Rule 29(c) Utah R. App. P., any party represented in the appeal will be heard within the time constraints of paragraph two".

Oral arguments will be limited to 20 minutes for any party represented. As the Court should be aware that the 52 parties in this case are not represented by counsel, and as such prohibited by Utah code - Utah bar association from representing any other person than themselves in the above referenced action. As such, 20 minutes for 52 Petitioners seems an unreasonable restriction on The People's right to petition the government for a redress of grievances.

We can find nothing in URAP 29, or the Practitioner's Guide to Oral Arguments, that addresses this unique set of circumstances. However, the Notice states: "Oral argument is limited to twenty minutes per side, unless otherwise ordered by the Court".

We hereby request that the time be increased to reasonably allow each petitioner the opportunity to present their case before the Supreme Court in this matter. We respectfully request the initial 20 minutes be increased to a minimum of 5 minutes per Petitioner, with that time being able to be pooled and/or reserved for rebuttal.
